

NEW OPERATIONS (INTERSTATE) FOR WISCONSIN IRP: Checklist

Applications with complete information will be processed the following business day and **WILL NOT BE PROCESSED** at our counter. Your application will be returned if any of the following information is not provided. Trans152.101 & 152.025.

Have you ever had an IRP account with Wisconsin? If yes, you must provide us with your previously issued account number.	
To verify your Wisconsin Residency -- You must have a valid Wisconsin Driver License. If someone else is doing the driving for your business we need to verify they have a valid CDL. If you have an Out of State driver, you must provide us the name and jurisdictions that issued the CDL. Please provide your Wisconsin Driver License Number _____. Trans 152.025 & Trans 152.101	
If you have any outstanding citations (parking tickets, unpaid fines - WI stats 340.01) you will need to pay them before we will consider your application.	
If you are a Wisconsin Business or an Out of State "For Hire Carrier" applying for an LC , you <u>MUST</u> be on file with the Wisconsin Department of Financial Institutions and be registered in the EXACT name of the registrant. Contact them at http://www.wdfi.org/corporations/crispix or at (608) 261-7577. <u>Status must be active and in good standing</u> -- Article II, Sections 210 & 218 of the International Registration Plan.	
If you are a FOR HIRE CARRIER you <u>MUST</u> have valid Insurance/Authority on file with the State of Wisconsin <u>BEFORE</u> we will process your application. Contact them at (608) 266-1356. -- Trans 176, WI Stats 194.41, Trans 177.03.	
INTERNATIONAL FUEL TAX AGREEMENT-- You will need to verify who is responsible for filing your Fuel Tax. Trans 152.05, WI Stats 340.01 Article IX of the IRP	
If you had previous IRP registration in any other Jurisdiction you will need to provide the following: a. Need a copy of previous registration (Cab Card). b. Need to report <u>ACTUAL MILES</u> for reporting period if coming from another Jurisdiction. We will need to verify with the jurisdiction where you were previously registered that you are in Good Standing with both your IFTA and IRP accounts.	
You must have a USDOT number issued in the EXACT LEGAL name of the registrant. If you do not have an USDOT number you can apply online at: http://www.safersys.org/ Phone number 1-800-832-5660	
You must provide a publicly listed Wisconsin telephone number in the EXACT name of the registrant applying for IRP. Article II, Section 218, Article IX, Section 906 of the International Registration Plan, WI Stats 341.405, Trans 152.101	

ADDITIONAL INFORMATION FOR OWNER/OPERATORS:

Owner/Operators must have a valid Wisconsin CDL. Please provide your Wisconsin Driver License Number _____. Trans 152.02, Trans 152.10, WI Stats 340.01, 341.08 & 341.405.	
Owner/Operators that are not filing their own Fuel Tax (IFTA) must provide us with a valid IFTA License Name and Account Number (Federal Employer ID Number or Social Security Number). You must provide a copy of the lease or a statement on lessee's letterhead stating who is responsible for filing the Fuel Tax and supplying the IFTA decals and license. If a copy of the lease is provided, you must highlight the language in the lease that applies to the filing of the Fuel Tax -- Trans 152.05, WI stats 340.01 Article 1X of the IRP	
Owner/Operators must provide a copy of the lease agreement or complete the Enclosed Lease Verification Statement. Article II, Section 234 of the IRP. Trans 177.07, Trans 152.101	
Owner/Operators must provide the USDOT Number for the company who you are leased to and is responsible for the safety of the vehicle(s) you are registering in IRP. This USDOT number will be verified on the SAFER website http://www.safersys.org/ prior to processing your application.	
Owner/Operators will need to provide us with a telephone number as stated above. However, if you only have a cell phone , you will need to attach a copy of your telephone bill with a Wisconsin phone number at the Wisconsin geographical address in the Registrant's name; billed to the established place of business address. Article I Section 218, Article IX, Section 906 of the International Registration Plan, WI Stats 341.405, Trans 152.101.
