WELCOME-INTRODUCTIONS

Kimberly Stephenson–Wisconsin Department of Transportation (WisDOT): Kimberly welcomed everyone to the meeting. She requested that everyone introduce himself or herself. Handouts were provided to each committee member upon registration and discussed after the introductions. Kimberly also reviewed previous meetings accomplishments. She then reviewed the agenda for the evening and introduced the first speaker, Tracy Gilliam.

Tracy Gilliam-Zoo Interchange Supervisor-WisDOT: Tracy mentioned the Zoo Interchange team is determining the impacts of refined alternatives and preparing the Draft Environmental Impact Statement (DEIS) to be federally registered. Nearly 500 people attended the May Public Information Meetings (PIM) and provided valuable input and ideas on the alternatives. Rosalind Roberson-WisDOT: Rosalind stated that the I-94 N/S Racine and Kenosha Labor Development Subcommittee took a charge to cultivate innovative solutions to communities in Racine & Kenosha for access to employment opportunities resulting from the I-94 N/S Corridor project by using divergent insight and resources. The Labor Development Committee sets aspiration goals that are not contractual but respected by contractors. The committee also receives project updates from WisDOT staff, Transportation Alliance for New Solutions (TrANS) provider updates, and shares valuable information regarding labor in the community.

Donna Eurick-United States Department of Labor (USDOL) stated that goals for labor in the State of Wisconsin, which vary by county are measured by hours worked. Rosalind stated that the I-94 N/S Racine and Kenosha Business Development Subcommittee analyzes opportunities for maximum Disadvantage Business Enterprise (DBE) participation on the I-94 NS Corridor while sharing community concerns and managing expectations for transportation projects. The committee meets every other month and provides project updates, DBE tracking information, and education. **Tom Walker-Wisconsin Transportation Builders Association (WTBA)** requested a list of certified DBE agencies in both Racine and Kenosha.
